# CALL TO ORDER

The meeting was called to order at approximately 5:30 p.m. with two members present.

# ITEM 1: APPROVAL OF MINUTES

Members Marcotte and Montaño reviewed and approved the minutes of the July 23, 2019, as drafted, by a unanimous vote.

#### **ITEM 3: UPDATES**

# (a) Public Access and Local Origination Channels by Hakim Bellamy, CSD.

Hakim provided a detailed update on the management and operations of the public access and local origination channels. CSD is currently managing both channels. Hakim discussed options for the future:

(i) Management and operations of the public access channel - CSD may issue a new request for proposals or, in the alternative, partner with a public entity for the management and operations of public access;

- (ii) Management and operations of the local origination channel CSD plans to contract directly with video producers for programs, broadcast that programming, and handle other management duties; and
- (iii) Community advisory board CSD plans to work with an advisory board on programming issues; this board may be the Cable Franchise and Hearing Board.

# (b) Posting information about internet speed testing on the Cable Board's website. Jane presented a draft webpage with information about testing tools. Members Marcotte and Montaño directed Jane to draft additional information about:

- (i) How a consumer would decide the needed speed:
- (ii) What a consumer should do if a problem is encountered; and
- (iii) What is open access and the Cities' Open Internet Pledge signed by Mayor Keller.

# (c) Summary of recent consumer complaints.

Jane presented a brief summary of complaints received by the City since January 2019. Comcast is required by its new franchise to provide quarterly reports of complaints. The first such report will be due this fall.
