I. CALL TO ORDER.

Mr. Montoya moved to approve the agenda excluding cases to be continued are LB 12-20, LB 14-20 and LB 17-06. Mr. Wartell seconded. Vote taken and passed 3-0.

Chairman Baca made a Motion that the Board go into closed session pursuant to Section 10.15.1.H.3 of the Open Meetings Act which allows for the closing of meetings for deliberation by a public body in connection with an administrative adjudicatory proceeding. Mr. Wartell seconded. A roll call vote was taken and passed 3-0.

Mr. Wartell made a Motion to return to open session. The meeting had been in closed session pursuant to Section 10.15.1.H.3 of the Open Meetings Act. Chairman Baca seconded. A roll call vote was taken and the Motion passed 3-0. The Board was in closed session to discuss LB 15-18 and no other cases were discussed.
