Mr. Marks served two terms as a member of the New Mexico Public Regulation Commission (PRC), where he was widely recognized for his understanding of regulatory law and finance, and for leadership in renewable energy development. As the only attorney member on the Commission during his eight years, Marks routinely presided over en banc hearings, and also was appointed as a hearing officer for several cases.

Commissioner Marks was the founding chair of the Western PUC Energy Imbalance Market Group, a two-term elected member of the Western Renewable Energy Generation Information System (WREGIS) board, a member of the Western Renewable Energy Zones Project Steering Committee and the Committee on Regional Electric Power Cooperation. He testified before the Natural Resources Committee of the U.S. House of Representatives on electric grid matters. He was appointed to chair reliability sanctions appeal panels for the Western Electricity Coordinating Council.

An attorney in private practice since completing his two terms on the PRC, Marks represents a variety of individuals, small businesses, and public entities in various litigation and advisory matters. Regulatory matters are a specialty of the practice, including representation of producers and patients in matters involving the N.M. medical cannabis laws, and utility law.

Prior to becoming an attorney, Mr. Marks led a national healthcare finance consulting practice. His practice focused on provider reimbursement and regulatory compliance for state Medicaid agencies for both fee-for-service and managed care delivery systems.
