VI. PRESENTMENT OF ORDERS.

Devon Moody, Assistant City Attorney appeared on behalf of the City. Rocky Gutierrez appeared on behalf of AFSCME. The parties submitted a Joint Motion and Order to Vacate Merit Hearing for LB 14-28 which was scheduled for November 16, 2018. The Board approved and signed the Order.

VII. BOARD'S REVIEW AND DISCUSSION ON THE ORDER ON APPEAL OF ADMINISTRATIVE DECISION IN LB 15-18.

Chairman Baca presented the Order on Appeal of Administrative Decision. Ian Stoker, Assistant City Attorney appeared on behalf of the City and asked the Board to allow the City to submit a dispositive motion prior to scheduling this matter for merits hearing. Chairman Baca stated that Board will enter a scheduling order for LB 15-18.
