If any section, paragraph, sentence, Section 3. clause, word or phrase of this ordinance is for any reason held to be invalid or 15 unenforceable by any court of competent jurisdiction, such decision shall not 16 affect the validity of the remaining provisions of this ordinance. The Council 17 hereby declares that it would have passed this ordinance and each section, 18 19 paragraph, sentence, clause, word or phrase thereof irrespective of any 20 provision being declared unconstitutional or otherwise invalid. 21 EFFECTIVE DATE.
