

**Bernalillo County Behavioral Health
Crisis Services Committee Meeting Minutes**

September 28, 2016

1. Call to order

Committee Chair, Rick Miera called to order the regular meeting of the Crisis Services Committee at 3:35 p.m. on September 28, 2016 at The South Valley Multi-Purpose Center. Chairman Miera thanked committee members for their continued participation. Reminded committee members to attend ABCGC meetings when ever possible.  - e. Emotional CPR brought up by Wayne Lindstrom as another method of teaching and training.
