

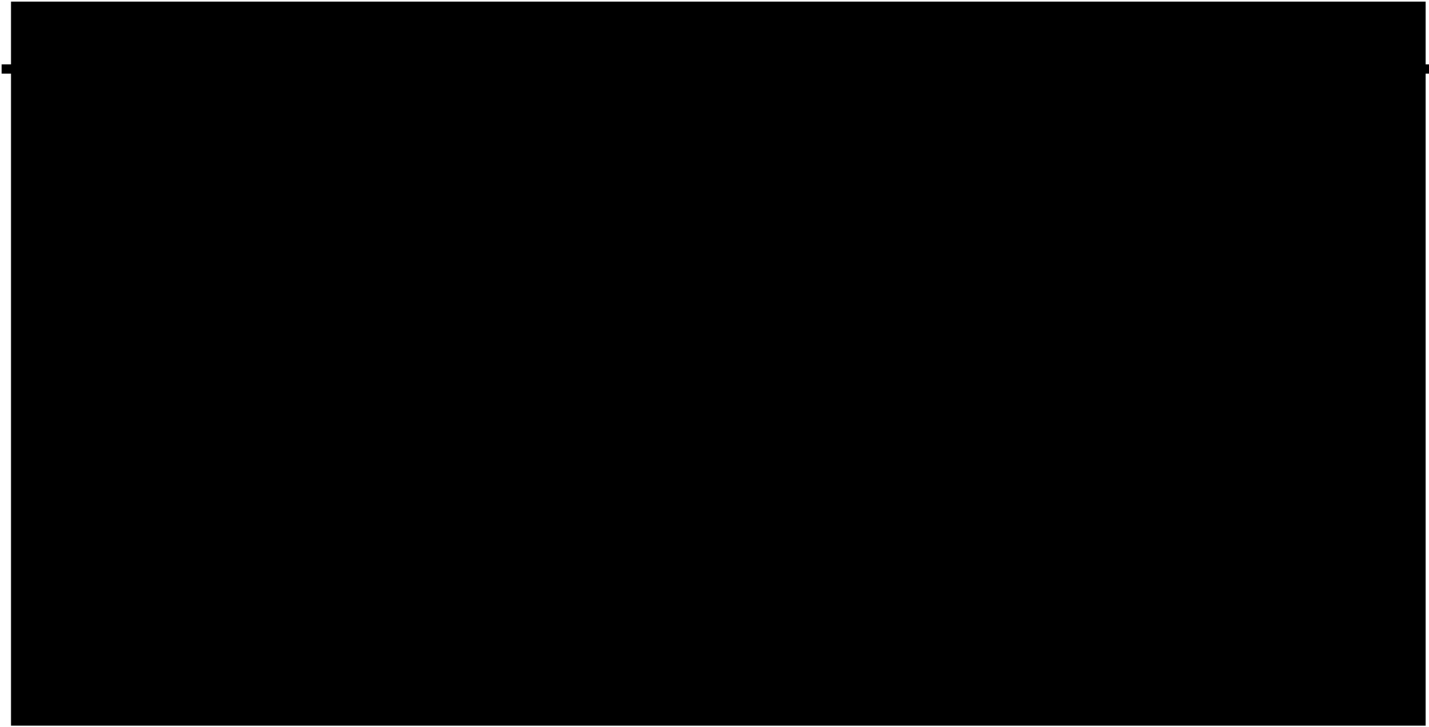

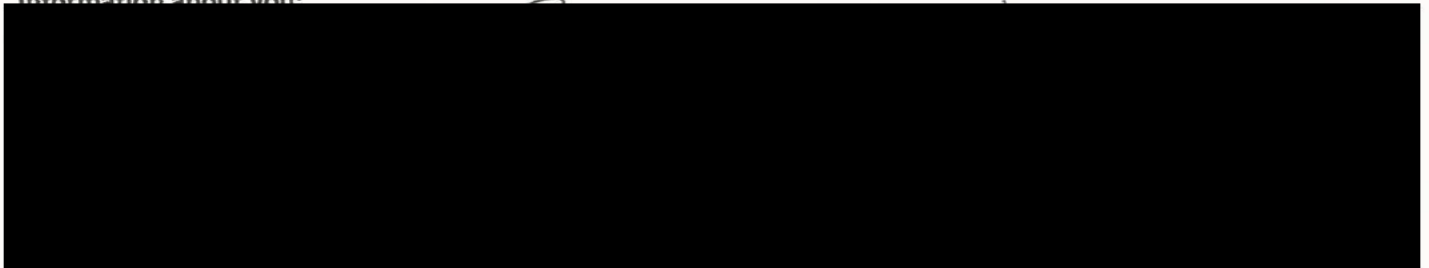

And instead of using force on me like they could of, APD took the time to calm me down and talk to me, and also let the intake people at MDC know what was going on so they would handle me accordingly.

Fast forward to today and ive been clean and sober for 2 years. I work at a local church and am a productive member of this community. All because APD did their job, and in doing so got me the help I needed.


To whom it may concern,

My name is [REDACTED] and I'm a social worker on the inpatient behavioral health unit at Presbyterian Kaseman hospital. I'm writing to you in order to express my appreciation and gratitude on behalf of the staff of this unit for an APD officer who assisted us recently with a difficult situation.

On Thursday, 9/17/2020 at about 11:00am, we had to discharge an individual from the inpatient behavioral health unit who was not appropriate for our services who then became violent and threatening to our staff. This individual was escorted off the Kaseman campus by our security personnel, but in the process he made graphic threats to go home and kill his mother in retaliation for our discharging him. I called 911 to request a welfare check at his mother's address of [REDACTED] then called his mother and grandmother to warn them of the threats he had made.

I later learned that officer Jessica Frosberg responded to the call and arrested this individual shortly after I completed my call to 911. I know that APD officers are very busy and I imagined this call would rate as fairly low priority, given that the limited information I was able to provide was somewhat vague, so I did not really expect such a prompt and thorough response. Officer Frosberg went above and beyond the call of duty to appropriately assess the situation and detain this individual, and I believe that the Albuquerque community was safer for her decision to act yesterday.

I would like for officer Frosberg to be recognized for her good judgement and willingness to help out. If there is any additional information that I can provide to help ensure this message of thanks finds her, please let me know. Thank you.

I just watched a You Tube Incident with Officer Byrd and three other officers. They had a confrontation with First Amendment Auditors. They could have arrested the auditors if they were aware of these two Cases. Please bring the to the attention of all the officers involved. Colten v. Kentucky , 407 U.S. 104 (1972) Colten is specifically clear. It is unlawful to interrupt the police performing their duties while conducting a legal road side motor vehicle stop or investigation. This would include a way to which the public has access as invitees or licensees.

Case facts.

Colten disobeyed several requests by an officer to leave a congested roadside where a friend in another car was being ticketed for a traffic offense. Judge ruled their was no bona fide intent to exercise a constitutional right to observe the ticketing process or engage the issuing officer in conversation.

Colten was correctly charged and convicted of disorderly conduct. The case is interesting. The judges decision for a finding of guilty was based on the defendant having no right to observe the ticket process, eliminating the word interference and any constitutional issue of free speech.

Officer Byrd was told to go fuck his mother
State v. Clay, Minnesota Court of Appeals, 1999).

May 10, 1998, the Winona Police Department received a report of a fight. An officer responded and saw one of the suspects, appellant Nathan Webb Clay, walking down the street with his hand bleeding. When the officer asked him what happened, appellant said that he had been jumped by four men but had "kicked their asses." Appellant then became agitated flailing his arms about and swearing at them loudly and called the officer a "white racist mother fucker." When a second officer arrived on the scene, appellant also accused the second officer of racism and told the officers that he wished their mothers would die.

Judges Ruling based on facts and evidence

I think it's entirely credible that those officers would be in fear of imminent physical harm. Indeed, [one officer] feared that he would be assaulted.

I also find that these officers were subjected to indignities beyond what they or other citizens might be expected to endure. These kinds of comments in a threatening manner can reasonably be expected to invoke retaliation of a violent sort.

Calling the officers white racist mother fuckers may be protected, wishing death upon an officer's mother is not. Judge ruled unprotected speech which constituted "Fighting Words"when viewed objectively, would likely provoke violent retaliation by the police officers. Accordingly, appellant was lawfully convicted of disorderly conduct.

Case on point, fighting words

The judge interpreted the speech, wishing death upon an officer's mother amounted to fighting words. Magistrates, Judges, or a Jury in other jurisdictions may consider that similar words directed at a police officer's family may be considered fighting words. Johnson, 491 U.S. 397 (1989), the Supreme Court redefined the scope of the fighting words doctrine to mean words that are "a direct personal insult or an invitation to exchange fisticuffs."
