When presented with the information that we were able to track the iPhone using the "Find My iPhone" application, Matt went above and beyond to attempt the recovery. He invited me along to the location (and proceeded to question a couple inhabitants around the apartment complex where the phone was showing its location. Matt's professionalism in talking with each individual showed great character and everyones' respectful response reflected this. Within a half hour we had a clear picture of exactly which apartment the iPhone was located (apartment). Getting to witness this first hand was inspiring and I gained a lot of respect for how effective and courteous police work can be.

Officer Fisher called for backup before attempting to contact the person suspected of possessing the phone. Officer Mike Warner and another fellow officer showed up promptly. In the meantime, it was discovered that the inhabitant of the apartment has a current warrant out for his arrest.

After multiple attempts of knocking on the door and contacting the suspect, he refused to come out. While frustrating, Officer Fisher was prepared to go through the necessary legal actions required to enter the premises. While getting ready to start filling out a search warrant, Officer Fisher received a personal phone call which required him to leave the scene. This was completely understandable and took much higher priority over recovering a stolen phone. Even under these circumstances, it was obvious that Officer Fisher was disappointed that he couldn't be of more help.

This entire situation did, however, allow me to provide my contact information to a couple of the neighbors who knew the father of the suspect (the father actually rents the apartment). The next day I received a phone call from one of the neighbors who had managed to contact the father who then recovered the phone.

Overall this was a great outcome considering the circumstances. None of it would have happened if

On May 41 was driving down San Mateo and turned west on MacLeod. I noticed a police car parked parallel to MacLeod in the parking lot of the Circle K convenience store and I saw a female APD police officer standing in front of a very large Native American individual laying on the sidewalk and leaned up against the building. The individual had no shirt on and I observed the officer looking around and had the impression that she was looking for the arrival of a backup vehicle. She was totally by herself.

I went down MacLeod and turned around and drove back and stopped my vehicle parallel to her patrol car. At about the same time a pedestrian who had been walking on the sidewalk crossed onto the parking lot and proceeded to the front of the store. The individual who had been laying on the sidewalk immediately leapt up and threatened to attack the pedestrian. The female police officer immediately took measures to calm the individual down and persuaded him to set back down and to continue drinking some water she had apparently provided to him.

Then to my utter astonishment a individual drove up and parked his van to the left of the gentleman on the sidewalk and when he got out of his van he walked between the officer and the individual on the sidewalk. I heard and observed her keeping the gentleman on the sidewalk calmed down and focused on her. Then if that wasn't enough a car pulled into the parking spot right next to the officer and got out and went into the store. Then if the public could not make it more difficult, another car tried to pull in to the spot that the officer was standing in. All this time the police officer kept the individual on the sidebar calm down in the area controlled and protected despite the mass stupidity she was subjected to.

I drove off because I felt that she had control of the situation and certainly did not need another distraction to the situation.

I chair one of the cities CPC's and the subject of de-escalation came to my mind. Not for our police officers, but for the citizens of our city. I remember the conversation that the first police officer on the scene of a shooting and vividly remember that the situation only got out of control after a crowd of people showed up and the individual got nervous and agitated. Our citizens must understand that de-escalation goes both ways.

I contacted Sharanne press who is the crime prevention specialists for the Northeast area command and requested the name of that female officer who exhibited such fine professionalism despite being subjected to the disrespect shown her by some of our residents. I want to complement officer Giselle Ronzone for exhibiting some outstanding crisis intervention and seeing to the welfare of this individual in need. (he was assisted by AFD)

I will see that the citizen police oversight board receives this information and that this fine officer has this information documented in her personal file.
