On the night of the incident I had been in a bar called The Library on Central Ave. Upon leaving the establishment I proceeded to walk toward a 7-11 to purchase some items and walk uber home. At which time after turning onto 3rd street from Central I heard only 2 footsteps behind me in quick meter. Before I could turn to see the person behind me I was struck ver the back of the head with what seemed like a blunt object because I was completely disoriented. The man beating me then proceeded to strike my face a few more times breaking my nasal spine and nose in 3 places. Luckily police parked or turning on to 3rd street saw the incident and ceased the man from this savage attack. With that being completely disoriented I heard the officers ask me to freeze but I was trying to stand up rot defend myself in a stupor. I was then taxed by the police for not complying with their order. I am not attempting to refute the taxing protocol that the officer used to detain me non-leathaly because quite frankly the police saved my life that evening, I am believe I told them that during my brief detainment. I would like to make an appointment to discuss bringing charges against the individual that followed me out or the bar, for reasons to rob me for the money he saw me pull out to buy a drink. I later recalled that I remembered he and his two accomplices at the bar watching me. I seek justice for the savage beating I endured for what to me is pocket change. Allow me to reiterate the fact that I am now bringing this to attention today because of the mental status I have been under for a month roughly over the pain from my injuries. When hospitalized I took pictures of the fact that there were no offensive wounds and many defensive wounds on my body, as well as the hematoma and swelling behind my ear where I was struck. I only realized that he robbed me the next day when I checked my wallet and realized the cash I had earned at work that evening was missing.

I seek charges being pressed against the perpetrator of this assault and battery and an audience with whomever was taking the report of this incident.
