ALBUQUERQUE, N.M. - A police officer in Albuquerque, New Mexico is being praised for how he treated students protesting President Donald Trump's decision to end DACA.

The Deferred Action for Childhood Arrivals program had protected nearly 800,000 young undocumented immigrants who were brought to the U.S. illegally by their parents. The Department of Homeland Security will now stop processing any new applications for the program.

Trump's decision has drawn mixed reactions nationwide. High school and college students opposing the move have staged organized walkouts. That's the case for a group of students at Highland High School.

During their walkout, the students were approached by an officer assigned to protect them, who AJ+ identified as Rob DeBuck.

Officer DeBuck praised the kids for standing up for what they believe in.

"You guys are an example for the rest of the city," said the officer. "If you want to get your word across, this is how you do it. I am so proud of the Highland students."

Officer DeBuck explained that part of the reason he was there was to keep the students safe.

"So remember when you're out here, most people are going to support you, but it only takes one (expletive) to pull off the road and mow you guys down," said the officer. "That's why I'm stationed out here, because I will die before I let them get to you."

The officer also offered some words of advice.

"Don't let anybody provoke you," he said. "If you have a redneck come by and say racial things, let him go. They want to see you guys fighting, so they can discredit you, so Trump can say 'See I was right.' Don't fall into that trap."

A video of the interaction posted by NM Dream Team has since been shared over 2,000 times and picked up by several national media outlets.

I am the victim of personal and business ID Theft and Fraud. It began 8/23/2016 to present. I was not made aware of the situation until May 10, 2017, when I received a Notice Of Investigation by Construction Industries (CID), at the request of the NM Attorney General regarding a complaint lodged against me and my construction company by a California company. Over the summer, I discovered who had stolen my business documents, changed my business tax number, opened a credit union account in my business name, entered into a remodel contract on an Albuquerque house, owned by the CA company received wire-transfer funds into the fraudulent CU account, only to discover that the had embezzled the funds for personal use and perpetrator of all above crimes, gain. I did not make an APD police Report earlier, as the crimes committed against me are primarily Federal Level. The FBI told me not to bother to make this report. However, I was instructed to close everything, my construction company, tax and revenue number, bonding attached to company, and the credit union account opened by --I have made progress with everything except the credit union, as (obviously unaware of its existence, I am not a signer - just owner of the business in which name the account is in. is only signer, so they are not very cooperative. At their insistence this past week, I am making a police report.

As stated above, I am the ongoing victim, both personally and professionally, perpetrated against me by . The ID Theft and Fraudulent behaviors began 8/23/2016 to present. some business and personal papers, changed my company tax and revenue ID number to a new name. used that "business Registration" document and possibly other items to fraudulently open a credit union checking account with the express, premeditated intent of receiving funds deposited by wire transfers and possibly other means for the sole purpose of embezzling the funds for personal gain. He proceed to misrepresent himself as a licensed General Contractor and owner of my business, entering into a contract with a company that flips homes around the country and is based in CA. illegally "established" a fraudulent persona, proceeded with his premeditated, complex, and and messy ID Theft and Fraud scheme to embezzle funds from any and all victims as possible, placing me at great risk legally, financially, and destroying me and my company's 34 year reputation. The remodel contract he entered into as owner of my company, and in my company's name, misrepresenting himself as a licensed general contractor was on a home in Albuquerque purchased by the California based "Home Flipping" business. embezzled approximately \$40,000. from the Manager of the CA company. I was not made aware of any of this until May 10, 2017, when I received a "Notice of Investigation" from Construction Industries Division (CID), at the request of the NM Attorney General on behalf of the CA company, that had filed a complaint against ME as the legally licensed General Contractor, and legal owner of the construction company, which Kelijaa had "taken over" and committed the above crimes. I had been told in June, 2017 by the FBI, and other Federal and State Agencies that since the charges were primarily at Federal and State Level, I did not need an APD report to be filed. I have been instructed to close EVERYTHING including the CU Account. When I tried to do the CU on 09/07/2017, I was told I had to file a police report.

Since you have changed methods by which reports of this nature (i.e. Business ID Theft, associated

fraud, embezzlement, bank fraud, interstate wire transfers - All Federal Offenses, and State Licensing offenses) are filed, no longer directly to your Detectives, now having to dispatch uniformed officers take white collar crime reports, I would like to make two comments.

First, the Two Officers who responded to my non-emergency call were terrific. I primarily spoke with Officer N. Elsman, Badge #5542. I had the impression the other officer was under Officer Elsman's tutelage, and I did not get his name. I commend Officer Elsman for taking a significant amount of time and effort to understand the events that had taken place in order make an accurate report. I had provided copies of the salient documents, trying for my own sake as well as his to only give the smallest number of documents, but cover the entire "road map" of egregious, premeditated, psychopathic(differs from 'sociopathic'in that they are both antisocial personality disorders, but a psychopath has the distinction of behaving in aggressive, perverted, or criminal behavior) activities. 1.... theft of business documents. committing ID theft and numerous serious Federal and State Fraudulent schemes is difficult to follow, I have had numerous businesses of my own as well as with my former husband over many years. I have a Master's Degree in Public Administration, and many years of business experience, and I find this slew of behaviors difficult to follow and understand. Officer Elsman took time to try to fully understand what happened, and follow my documentation of how pulled off the numerous crimes. I greatly appreciate the time and effort he put in to understanding why I attached certain documents together, and the logic of the entire mess which I have been compiling and organizing all summer.

Second, I would like to point out that it does not seem to be the most efficient method by the APD for filing such complicated, predominantly business related reports. Most of these young officers would not have taken the time Officer Elsman did. Most would have glazed over at the beginning of the convoluted and numerous crimes, only to make some simple report which now goes through many channels before winding up in the hands of a Detective. It seems both inefficient for the victim, and most likely looses specifics in translation, like the kindergarten game of having one person whisper a statement to the person next to them, then on to the next, and next etc. only to have the last person state what they had whispered to them, and see how different that statement is from what was originally said. Why not allow the uniformed officers to do what they hired on and were trained to do, and allow victims of white collar crimes to go directly to the detectives who will handle what they can directly. As most of these crimes are not handled within the jurisdiction of the city crime arena, I do not understand the waste of staff time, especially as there is such a shortage of uniformed officers capable of handling assaults, burglaries, traffic accents, and other violence.

What Outcome are you Seeking?

I want to be thoroughly investigated for his crimes, and prosecuted to the fullest extent of the law, Preferably with the outcome including prison time. I want him barred from any involvement with the construction industry, thus allowing him access to more victims - as he states in the short letter he sent to me May 12, 2017 requesting that I change my company name to free it up for him to use in a design/build capacity with another general contractor!

Finally, I would like the US Eagle Federal Credit Union held responsible for aiding and abetting, collusion, and lack of due diligence allowing him to open the checking account with them using documents from my company, all of which have my name and contact information printed on them. I believe I am entitled to receive full remuneration of every dime deposited into the account opened in my company's name. I have spent the entire summer documenting and researching what to do to clear my name and move on with my life. Due to inability to work during this research, my mortgage is in default.
