Please note that this is an older case and that the Force Review Board would have been attended by my predecessor, former Executive Director Ed Harness.

My review of the evidence shows that on November 18, 2018, police received a call about a domestic disturbance in which the subject, Mr. J, was highly intoxicated and making threats with a fire arm. By the time officers arrived on scene, the home in which the domestic situation had been unfolding had been vacated by Mr. J's wife and children, who took shelter at a neighbor's home across the street.

Upon arrival, Officer #1, who was CIT trained, began engaging Mr. J in conversation and working to deescalate the situation. Mr. J asked to speak with an officer he knew from his National Guard Unit. Officer #1 explained that this officer had retired, but asked about other APD officers in his unit in an attempt at rapport building. During this conversation, Officer #1 repeatedly asked Mr. J to show police his hands. Mr. J

repeatedly refused and made threats towards officers. This conversation went on for several minutes.

Officer #1 continued the conversation, assuring Mr. J that police didn't want to hurt him and that they just wanted to talk to him without the gun. During this conversation, Officer #2 noticed Mr. J pointing his gun at officers. Officer #2 responded by firing a single round at Mr. J. Officers were unclear at this point whether or not Mr. J had been struck by the shot.

As Sergeant #1 was radioing dispatch that a shot had been fired, Mr. J opened fire on officers, firing several shots in their direction. When there was a brief pause in the shooting from Mr. J, Officer #2 returned fire, firing nine shots back at Mr. J. At this point, Mr. J fled back into the house.

Mr. J eventually surrendered to officers. He was transported for medical treatment of a gunshot wound to his arm. Mr. J survived his injury and his criminal charges from this matter are still pending.

Finding: The CPOA finds that the uses of force in this matter (the shots fired by Officer #2) were, by a preponderance of the evidence, within policy. These uses of force did not violate APD policies, procedures, or training.

Please note that this is an older case and that the Force Review Board would have been attended by my predecessor, former Executive Director Ed Harness.

My review of the evidence shows that on December 12, 2018, a woman called 911 after the subject, Mr. R, attempted to mug her at gunpoint. Officer #2 contacted the subject at San Pedro and the arroyo. Officer #2 told Mr. R to stop and show his hands. Mr. R, instead, ran. Officer #2 gave chase into the neighborhood.

Mr. R jumped into a backyard and Officer #2 heard multiple gunshots. The homeowner into whose yard Mr. R jumped contacted Officer #4 and told him that Mr. R had jumped into his backyard and shot and killed their dog. Officers #1, 2 and 4 got the family safely out of the house, cleared the house, and found the dog.

Officers #1, 2, and 3 then moved next door and contact the homeowner. They were given permission to enter the backyard to search for Mr. R. Officers #1 and 2 entered the backyard. Officer #1 identified himself as Albuquerque Police and ordered anyone in the

yard to make their presence known. Officers crossed the back yard and came to the side of the house, where Mr. R was hiding behind a wheelbarrow. Mr. R pointed his handgun at Officer #1. Officer #1 responded by firing at Mr. R.

Mr. R died from his wounds.

Finding: The CPOA finds that the uses of force in this matter (the shots fired by Officer #1) were, by a preponderance of the evidence, within policy. These uses of force did not violate APD policies, procedures, or training.

Please note that this is an older case and that the Force Review Board would have been attended by my predecessor, former Executive Director Ed Harness.

My review of the evidence shows that on February 13, 2021, Officer #1 spotted the subject, Mr. G, on a property which Officer #1 knew had been deemed substandard by the city and which was not supposed to have any people on the property. As Officer #1 approached the property to speak with Mr. G, Mr. G fled on foot.

Officer #1 gave chase. He shouted after Mr. G to stop and identified himself as Police. Mr. G ignored the officer's commands.

As the chase proceeded, Mr. G turned and fired at Officer #1. Officer #1 felt something hit his face (it was later discovered that ricocheted material struck him in the lip). Mr. G shot at Officer #1 again, repeatedly. Officer #1 returned fire. In all, Officer #1 wound up firing 18 rounds during this exchange of fire.

Mr. G wound up hiding from officers in an abandoned refrigerator on the property. He was eventually taken into custody by other officers. He was not injured in the incident.

**Finding:** The CPOA finds that the uses of force in this matter (the shots fired by Officer #1) were, by a preponderance of the evidence, **within policy**. These uses of force did not violate APD policies, procedures, or training.
