

TOP 10 NON-MEDICAL CALLS



These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

1/11 - Apartment Fire: AFR was dispatched to 3210 Tulane DR NE in fire district 19 for reports of a residential structure fire at the Salida Del Sol apartment complex. Station 19 units arrived on scene and declared a working fire with smoke showing on the non-visible side of one of the apartment units. Fire crews were able to make access into the complex through a security gate and located the fire in the utility room. Several apartments were evacuated as firefighters quickly extinguished the fire and checked for extension. An all clear was declared signifying that the occupants of the adjoining apartments had been safely evacuated. A total of 13 fire apparatus were on scene to assist with fire operations.

1/14 - Residential Fire: AFR crews responded to 10100 Erlitz NW in fire district 22 for reports of a structure fire. Engine 22 arrived and reported smoke coming from the attic of a single family residential home. AFR crews were able to extinguish the fire and prevented it from spreading to other nearby homes.

1/14 - Residential Fire: AFR responded to a mobile home fire located at 6901 Zuni SE in fire district 5. Upon arrival Engine 5 reported flames and smoke coming from a mobile home. The residents were able to self evacuate prior to AFR units getting on scene. Crews quickly extinguished the fire. Unfortunately, the mobile home was a total loss but one dog was resuscitated. There were no injuries to civilians or firefighters reported.

1/25 - Bosque Fire: AFR crews were dispatched to the area of Marquez and Tingley in fire district 1 for reports of a brushfire in the Bosque. Upon arrival Engine 1 confirmed the wildland fire with 10 foot high flames. Six units were dispatched to the area to fight the fire. Despite increasing winds, fire crews were able to contain the fire to 1/10 of an acre within one hour.

1/26 - Residential Fire: AFR was dispatched to 3410 Aztec Rd NE in fire district 19 for reports of a possible structure fire. Engine 19 arrived on scene and reported visible smoke from the first floor and AC unit of one of the apartments. The fire was brought under control within 10 minutes of their arrival. Damage to the structure was contained to the initially identified fire occupancy with fire spread limited only to the AC unit of that apartment. No injuries were reported to civilians, but the one individual was transported to a nearby hospital for precautionary evaluation.

1/27 - Residential Fire: AFR crews were dispatched to a single-story detached structure at 920 Douglas MacArthur Road Northwest in fire district 6. Engine 10 arrived on scene and reported flames and smoke from a detached structure. Fire crews were able to extinguish the fire within 20 minutes.

1/29 - Commercial Fire: AFR crews were dispatched to 2435 Wyoming Blvd in fire district 9 for a commercial structure fire. Upon arrival Engine 9 reported smoke and flames coming from a single-story three unit strip mall commercial structure. 11 units were dispatched to the fire. Fire crews were able to get the fire under control within 15 minutes. There were no injuries to firefighters or civilians



1. **AFR firefighters attended a career fair at El Dorado High School as part of the AFR High School Ambassador program and were able to interact with the students and show them some tools of the trade.**
2. **AFR had the privilege of hosting a tour of our Fire Academy facility to students as well as college and career counselors from South Valley Academy. These efforts help connect students looking for possible career choices to learn about a future in the fire service.**
3. **Mayor Keller and Fire Chief Gallegos honored AFR's Veterans for their military service and continued work for our city community. Veterans were invited to the AFR Training Academy to be recognized and receive a challenge coin.**
4. **AFR Chief Gallegos joined Mayor Keller and other City leaders to announce plans for a new Public Safety center in SW Albuquerque. The new station will add the additional units we need to better serve the community and drastically lower response times for people in this area. The city also hopes to add an Albuquerque Police Department substation and an Albuquerque transit station to the six-acre property.**



FIRE MARSHAL'S OFFICE

INSPECTIONS DIVISION

- With the beginning of the new year, FMO has begun conducting all 145 annual inspections of schools. Working closely with APS's maintenance and operations division, FMO inspectors will ensure all life safety systems are maintained and in good working order.
- The inspections office is happy to welcome Lieutenant Mike Segura to the team. Lt. Segura worked with the Plans Checking office for 6 months where he gained valuable knowledge making him an asset to our office. He is both IFSAC inspector I & II and maintains both of his ICC inspector's I & II. We also would like to welcome back Inspector Kurt Widerkehr to the team. Inspector Widerkehr has spent time in our office as well as the ADAPT office where he has gained a considerable amount of knowledge that is invaluable to our office. He too maintains both IFSAC and ICC I&II certifications.
- This month we also did a full inspection of the Netflix studios to ensure all life safety systems are in working order. The Netflix studios continue to expand and maintain an excellent working relationship with our division.

ADAPT

- ADAPT has 149 properties that have been formally brought into the program, 91 have been cleared from the program and 58 are still in the program at different stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- There are 110 properties on the Unsafe Buildings list. Four new properties were added to the list this month. The properties are labeled on the First Due application with a white "X" on a red background. In the field these properties are marked with a red spray painted "X" and the letters "AFR" under it.

FIRE INVESTIGATIONS DIVISION

- On January 8, 2023, AFR Investigators were contacted by Squad 3 Captain for a gas leak at 2101 Louisiana Blvd. NE at the Marriott Albuquerque hotel. A portable consumable ignition device and some burned tissue paper were found near a broken gas line on the south side of the hotel. Hotel has surveillance video of an individual attempting to set the gas main on fire and can be seen walking near the gas main and then running away. Arson investigators were contacted to conduct an origin and cause investigation. Fire investigators arrived on scene and met with the Squad 3 Captain and he advised of us of the information pertaining to this call. At 00:30 hours hotel security heard a whistling noise on the south side of the hotel. Security found that the main gas meter had been tampered with. A small line was cut by an unidentified individual, and it was attempted to be set on fire with a portable consumable ignition device, some tissue paper was used as the first fuel. Fire investigators spoke to the hotel manager and he advised that security video shows an unknown individual who could be seen walking to the south side of the building at 19:25. The surveillance was reviewed however, the footage could not assist with providing a positive ID of the suspect.

- On January 10, 2023, fire investigators responded to 2433 Wyoming Blvd NE. to conduct the origin and cause of a fire incident involving a vacant commercial office building. Upon fire investigators arrival to the incident, it was noted that the office building had been burglarized and a small fire had been started in the middle office space located on the north side of the hallway.
- From January 23-25, 2023, Lieutenant Gunderson attended APD's Drone Course and will soon become the division's first drone pilot. Obtaining a drone for the division will assist in the investigation process by gathering photos, videos, and aerial images.
- On January 26, 2023 Lieutenant Gunderson and Wheezy responded to Grants to assist New Mexico State Fire Marshall's Office, The Navajo Nation, and Cibola County Fire with the investigation of a suspicious vehicle fire that involved a deceased male individual. The cause of the death was unable to be determined but was presumed to be a homicide/suicide. We assisted in locating key items of evidentiary value that will assist in the resolution of the case.
- On January 28, 2023, fire investigators responded to a commercial building to conduct an origin and cause investigation. Fire crews did a great job of extinguishing and containing the fire to the occupancy. Fire investigators are working the case for any criminal intent.
- On January 30, 2023, fire investigators were notified and responded to an outside fire near the foothills. An individual with a criminal trespass notice against him was allegedly seen starting a series of small fires in the area. Investigators responded to the area and searched for the individual. Fire investigators are working with APD to create a crime stoppers bulletin.

PLANS CHECKING

- SAMS (Southwest Aeronautics, Mathematics and Science) Academy is a free, public STEM charter school located on Albuquerque's far west side adjacent to Double Eagle II Airport that prepares students in grades 6-12 for college. The 37,125 Sq. ft school located at 6441 Ventana Rd NW passed their fire final inspection and obtained their certificate of occupancy.
- Plans Checking is working with the Planning department on replacing the current POSSE system with another enterprise management software service called Tyler Technologies. This system can impact our plan review process. We have started preliminary meetings and look forward to help implement this software that will deliver better and faster assistance to the public with greater transparency and accessibility.

HUMAN RESOURCES

- Leave Management Policy completed and approved by LMC. Will upload into Target Solutions shortly. A memo notification will be sent out.
- Employee Referral Incentive MOU written. Once MOU signed, the goal is to make effective for the current 101st Open Enrollment process. Since Open Enrollment has already started, AFRHR and Training has identified an internal method that would create a fair and equitable process for all applicants to be identify referral.

TRAINING ACADEMY

Professional Development

- A two-week Lieutenant Certification course beginning January 23rd, with 12 students training for duties at the officer rank. Thank you to all adjunct instructors who were able to make this course happen!
- A Two-week Driver Certification Course started on January 9th with 12 driver students. All successfully passed the exit exam and are now currently working on their task books.

Suppression Division

- Academy Staff conducted a 2 day 'Burn in' training on the new burn structure. This allowed the staff to learn about the capabilities of the structure and maintenance of the two burn rooms, within the multi-story structure. The first training burns for field units are scheduled for February.
- All 12 members from the 98th cadet class came up for quarterlies. Group 1 tested out on their rescue certification with multiple re-tests needed and group 2 received their rescue orientation and were assigned their task books.
- The Academy Staff experienced an unprecedented turnover in January, with 5 of the 8 positions changing personnel, including the Training BC, Training Captain, and three new Driver/ Instructors. This new staff has been training aggressively and is ready for the 100th cadet class scheduled to start on February 13th,2023.

HEART

- HEART provided 62 rides with its “Rides with HEART” rideshare service.
- The HEART Home Modification Program provided 42 home modification installation services. These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 37 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with “Leave Behind Narcan Kits” to provide to community members in need.
- Fentanyl Strips to Frontline units has been completed and supply will be ongoing.
- Buprenorphine Program- Inserting information for suboxone treatment in the LBN kits. Individuals will receive access to an app with counseling, cognitive behavioral therapy and contingency mgmt. Plus, monetary rewards for compliance. Will be an ongoing push.
- To date, the HEART BEATS stroke discharge program has received over 316 referrals for service. HEART is currently working with 60 patients in the program.
- Pediatric Assessment Program is currently being forged. AFR HEART division will partner with UNM Hospital for pediatric assessments. The mission is to provide a patient visit with assessment 24-48 hours post discharge for sick children who were discharged from the hospital with oxygen. Details are still being worked out. The go live date to be determined.
- HEART personnel attended Pediatric emergency department shadowing shifts in preparation for the new pediatric assessment program.
- Be Brave Fall Prevention Classes taught at Sandia Vista Senior Living.
- Lt. Valerio-Hirschfeld is teaching Community Health Worker class. Three of ten classes have been completed. The class is made up of AFR members, AMR, Sandoval County Fire and Santa Fe County Fire,
- HEART met with Innovage New Mexico PACE to establish a solid resource that many of our geriatric patients could benefit from utilizing.
- Met with Adult Protective Services to reestablish an old partnership.
- Educated students about the division at the Jan. Lieutenant Certification course.
- Provided support fill for frontline units.

BEHAVIORAL HEALTH

- Facilitated VO2 Max for all of January
- 1st Quarterly Peer Support meeting
- 1st Quarterly Chaplain meeting
- Attended BH committee meeting
- Attended H&W Ambassador meeting w/ the city
- Met with 6 members
- Conducted Debrief for Engine 3 crew
- 2 Chaplain call outs for the Community
- Met with BCFR Peer Coordinator about creation of H&W app.
- Met with BCFR’s new Chaplain
- Completed 4 weeks of the Saturday Cadet Prep course

RECORDS MANAGEMENT

- Supplied data revolving around outside/encampment fires to assist in matching appropriate City resources to community need. Also, created inputs in the NFIRS documentation form to capture more accurate data on this variable.
- Continued to work on the build out of Continuum:
- Developing monitors that will allow for real time feedback and intervention on specific areas of interest (Fire Marshal's Office follow up, Peer Support follow up, Physical Assaults on Providers and EMS specific case studies AFR is involved with)
- Developing station dashboards to relay statistical information as well as messaging from the Fire Chief and Divisional updates.
- Began the mapping process of incident times and other statistical data from Premier One CAD to ImageTrend Elite. This will create a single source for all of AFR's statistical analysis and improve the accuracy and consistency across all variables.
- Assisting with AFR's professional development program, teaching EMS & Fire documentation in the Lieutenant Certification course.
- Assisted in getting EKG review software on EMS Supervisor's MDT. This facilitates the capability to have on scene debriefs, following critical emergency medical responses.
- Assisted Santa Fe Ski Patrol with properly uploading EMS documentation to the State's database.

EMS TRAINING

- This January, 16 AFR Firefighters and 4 APD officers graduated from the EMS Training Division's Fast Track EMT-B course. All of them passed the National Registry test on their first attempt, and are already making a difference in their new field assignments.
- The division filmed and edited multiple training, social media, and case study videos with Dr. Pruett.
- A Lifesaver Training session was conducted with several of Manzano Day School's administration and staff. This training prepares school staff to respond to a broad range of emergencies, improving the safety of students, and our community at large.

QUALITY ASSURANCE

- PECMO is officially operational again. The QA Division has facilitated all required training between AFR and UNMH in an effort to further integrate this life saving procedure in the pre-hospital setting.
- The QA Division has addressed multiple EMS operational issues through AFR's QA process. In cooperation with our contracted ambulance provider we have seen a continued monthly decrease in AFR transport of EMS patient's, and a significant decrease in both "Critical Status" & "Level Zero".

PHARMACY

- Amiodarone and Nor-Epi delivered to units.
- Droperidol purchased for future distribution.
- LP15 and LUCAS batteries on back order. We have back stock that is sufficient for now. Working with Stryker on the ordering of new batteries.
- Stryker service contracts for LP15 and LUCAS is underway. New contracts should be active in the next few months.
- Modem issue (the 25 modems in the Pharmacy were not transmitting). The issue was resolved, the data plans for the devices were canceled. Capt. Buck re-established/activated them, the modems are transmitting now.
- Special request by HEART for pediatric medical kits have been ordered. Some of the items are on back order.

SPECIAL OPERATIONS**HEAVY TECHNICAL RESCUE**

- This month our HTR program was able to send many of AFR members to various trainings. This includes Rope rescue operations, Confined Space Technician and Advanced vehicle extrication course. The continuing advancement of our firefighter education and knowledge is critical to maintain a safe effective and efficient service to keep all our citizens coming home.
- Upcoming changes to the program will help grow our capabilities and responses. The main change of moving to station 4 will reduce response times to a greater portion of the city and give the opportunity of a training facility in house to facilitate the retention of the critical skills required by HTR program. Thank you for your support of these changes as the program blossoms of the next many years.

HAZMAT

- AFR Hazmat coordinator attended another meeting with San Juan Water treatment with Bernalillo EOC for schedule training days. It is unknown if San Juan water treatment would like a hands-on exercise or table-top. Another meeting is scheduled for February.
- AFR members attend a two day REACT-RAD class hosted by Sandia Nation Labs. The purpose of the class was for the medical emergency on responding and handling a trauma patient exposed to a radiation source. The benefit for AFR is, according to the REACT team, treat the trauma first and don't worry about the radiation. Always remove the patient away from the source.
- Safeware hosted a "Hazmat/CBRN Trends to Watch in 2023" webinar. Link was provided to stations 13/17 to attend the webinar. The webinar included response to Electric Vehicles (EV). There is no certain way to attack an EV fire. Should we go offensive, defensive, or non-intervention. There is no SOG across America for an EV fire. Also covered were how terrorist attacks are on the rise, not just from other countries, but within our own backyards. Chemical suicides are a big thing, easy websites to acquire a suicide kit called "sodium nitrate the suicide box".

WILDLAND

- For the month of January, the Wildland Division is making the necessary arrangements for our annual Pack Test, which will be held at Balloon Fiesta Park again this year. Our annual RT-130 refresher training has been assigned to everyone via Target Solutions, and is due by March 31st.
- The division received grant funding to purchase 10 4-stroke pumps that will take the place of our Mark 3 pumps for local response. This change comes in the wake of increased cost and repair times of our Mark 3 pumps. The Mark 3 pumps will be cached until needed for deployments or local complex incidents.
- The Wildland Division has had a substantial increase in vegetation fires so far this year, due in part to a drastically dry winter.

FOC

- The month of January saw many of the normal staffing issues for personnel in the FOC. Having numerous newly-graduated firefighters allowed the FOC to staff fire suppression trucks well during the day. These firefighters were placed on a 40 hour schedule to cover some of the more heavily used leave days (mostly weekends) but left many of the same challenges to staff vacancies during night shifts. However, in mid-February the remainder of the new firefighters will hit the streets with their newly-acquired EMT-Basic licenses and all of these recently graduated firefighters will be placed on one of the 3 48-hour shifts to allow for more optimal around-the-clock staffing. As the Academy staff hold unprecedented numbers of upgrade certification courses throughout 2023, we will see more personnel able to upgrade to the rank of Driver and Lieutenant, thereby lessening the strain of filling vacancies at the Driver and officer rank for staff in the FOC. A continual challenge in staffing remains in filling paramedic spots. Multiple personnel have stepped up to work these vacancies while we continue to work to address the shortage at this licensure level.

SPECIAL EVENTS

- The Special Events dates for 2023 have been set by the Arts and Cultural Services department. AFR will provide EMS coverage for these events starting with the City of Albuquerque birthday on April 22nd in Old Town.
- Planning continues for the 2023 Albuquerque International Balloon Fiesta. Several city departments (along with AFR) are working to draft a rewrite of the current agreement between the city and AIBF. This rewrite will give City public safety more command and authority in specific potentially more severe situations where quick actions and decision-making can allow for increased safety for the citizens and visitors at the event. Regardless, AFR and APD continue to work toward improving on a Unified Command where communication and coordination allows for quicker responses within the Balloon Fiesta Park during events.
